YEAR IN REVIEW AND A LOOK TO THE FUTURE

A MESSAGE FROM EXECUTIVE DIRECTOR ALDO RADAMUS

The last 12 months at Ski & Snowboard Club Vail (SSCV) have brought unprecedented achievements and accomplishments.

After completing a comprehensive and nearly two year long process, SSCV received "Gold Medal Club" certification from the United States Ski & Snowboard Association (USSA). The certification team examined all aspects of club operations including governance, SafeSport, finance, communications, mission, vision, athlete experience, development and service to the community.

The annual USSA Awards Banquet saw SSCV win awards as Club of the Year, Alpine Club of the Year, Snowboard Club of the Year, Freestyle Club of the Year and Freeskiing Club of the Year. Never before (and likely never again) has one club won 4 of the major individual sport club of the year awards together with the overall Club of the Year.

Twelve of our alumni and current athletes competed at the Sochi Olympics and inspired us with their poise, character and performances including two Gold medals and one Silver.

While we rejoice in the athletic success of each athlete, our ultimate objective as an organization, from the six year old Future Stars athlete to the Olympian, is to spark a dream and ignite a passion which will provide focus and teach life lessons through the vehicle of competitive snowsports, enabling these youngsters to remain healthy of mind and body and go on to succeed in their adult lives. This past year alone, college acceptances for our athletes included Bates, Colby, Dartmouth, Harvard, University of Denver, University of Vermont and Williams adding to the legacy that regardless of what path SSCV alumni take, they have gone on to be successful, resilient and active people in all walks of life.

The Scholarship program has made strides this past year, with nearly 20% of our athletes (110+) receiving financial aid, exceeding \$170,000 in total. Ski and Snowboard Club Vail is moving further toward our goal of ensuring that any child wishing to pursue their dreams in snowsports can reach their potential regardless of their means.

Now in the club's second year of a comprehensive education program, the last two weeks of October are filled with educational opportunities for coaches, athletes and parents. Including topics from coaching techniques, sports parenting, concussion protocols and from inspirational speakers to communication strategies, van safety, SafeSport and club policies; this commitment to staff development has made a tangible difference in our programs and sets the national standard among snow sports clubs.

These extraordinary accomplishments of the past year would not have been possible without the continued support of Vail Resorts, current and past families, alumni, supporters and friends throughout the community. I am eternally grateful for all that our extended SSCV family does to provide life changing opportunities to the youth of the Vail Valley.

As we look forward, many opportunities remain.

Progress continues towards the re-development of the clubhouse. Approval for the project has been received from the Town of Vail with plans calling for an expansion of the club's space from 6,000 sq. ft. to 28,000 sq. ft. Funding for the project will be obtained from the sale of 1 or 2 penthouse residential units on the upper 2 floors of the new building.

The proposal to expand Golden Peak to create much needed training venues for the kids is under review by the US Forest Service with hopes that an approval would allow construction in the summer of 2016.

The Residence Center plans create subsidized housing opportunities to attract and retain great coaches and meet the need of kids currently hosted with families. The project will be self-sustaining once completed. The goal is to house the first staff and students in the fall of 2016.

Most importantly, an Opportunity Fund is being created to provide accessibility for local kids and insure that advancement is based on effort and performance.

Together, we will Fulfill the Dream in 2015!

SSCV PROGRAMS AND ACADEMIC PARTNERS

Founded in 1962 to provide training and competition programs for aspiring young ski racers, Ski & Snowboard Club Vail (SSCV) is the Vail Valley's oldest non-profit organization. Today, the 501 (c)(3) non-profit organization remains true to its roots by instilling its core values of character, courage and commitment in more than 600 youngsters who participate in its full-time and part-time Alpine, Freeskiing, Freestyle, Nordic and Snowboarding programs, along with, a seasonal mountain biking program and, new to the 2014-2015 season, the Ski Cross program and Alpine Bank Get in the Gates Recreational Ski Racing Program.

As a youngster's passion for their snowsport increases, so does the need to provide them with more time on snow along with more time developing the physical and mental attributes needed to achieve their dreams through SSCV's full-time programs.



Through strong partnerships, full-time SSCV student-athletes can pursue their passion for snowsports in parallel with focusing on a rigorous academic curriculum at one of the following SSCV Academic Partners:

• VAIL SKI & SNOWBOARD ACADEMY

• VAIL MOUNTAIN SCHOOL

This past year, SSCV formalized its full-time athlete admissions process for all full-time applicants, regardless of where they attend school. Through this process SSCV is able to learn more about all aspects of the youngster, not just their athletics, to assure their readiness and success, both on snow and off, as they seek to take their sport to the next level.

Full-time athlete admissions numbers, including those attending Vail Ski & Snowboard Academy and Vail Mountain School, were at an all-time high in 2014.





At the Organizational Level

This past year SSCV enjoyed unprecedented achievements and accomplishments, marking success not only at the organizational level but also at the development and elite level across all snowsports. Always striving for continued excellence, in 2014 SSCV was named the United States Ski & Snowboard Association (USSA) Club of the Year, Alpine Club of the Year, Freeski Club of the Year, Freestyle Club of the Year and Snowboard Club of the Year (having received the Freeski Club of the Year and Cross Country Club of the Year in 2013). In addition, an SSCV Snowboard Coach was named 2014 USSA Snowboarding Domestic Coach of the Year.

SSCV also received "Gold Medal Club" certification from USSA, a coveted recognition received after undergoing a comprehensive review process that spanned almost a two year period.


OFF-SNOW AND OFF-SEASON TRAINING AND CONDITIONING

Ski & Snowboard Club Vail provides a robust year-round training environment, both on snow and off, that supports all aspects of an athlete's development. The campus at Vail Ski & Snowboard Academy (VSSA) provides a perfect venue to support its athletes in strength training and conditioning, acrobatic progressions, sports psychology and nutrition counseling along with return to sport preparation in partnership with Axis Sports Medicine. The addition of the Minturn Fitness Center has been instrumental in taking SSCV's Human Performance programs to the next level.

SSCV athletes enjoy a local season that extends from October through May with out-of-state experiences available throughout the remainder of the year, including a club wide camp at Mt. Bachelor in June with on-snow training, world-class mountain biking and a variety of other dryland activities. SSCV also offers a variety of off-site water ramp and trampoline camp experiences in the summer and fall which provide further opportunities for athletes to take new tricks to snow which compliment on-snow airbag progressions.

About the Newly Opened Minturn Fitness Center

In August 2014, SSCV opened its doors to a multi-million dollar Human Performance Center known as the Minturn Fitness Center. The center is located at the VSSA campus and was made possible through a partnership between SSCV and the Town of Minturn along with the generous support of donors. It serves SSCV athletes, the residents of Minturn and members from among our SSCV parent community and the Vail Valley.




FY14 Financial Highlights


SSCV completed FY14 with a modest surplus


