



## Howelsen Hill Ski Area—Use Agreement and Release

The following rules and conditions are terms of all pass purchases and ski area use. In consideration of use of Howelsen Hill Ski Area the passholder agrees to the following: 1. Only the rightful owner whose picture appears on the photo identification card may use the pass. It is not transferable either for money or general use. If someone uses the pass other than the passholder, the penalty may result in arrest and loss of the pass for the remainder of the season, without refund. 2. The rightful owner at all times while skiing/riding at Howelsen must wear the photo identification. The pass must be shown to the ticket checker or lift attendant prior to boarding any lift. Refusal to comply will be considered abuse of the pass and pass holder will be penalized accordingly. 3. Lost/forgotten passes must be reported immediately to the concession stand and the procedure below will be followed: 1st offense & 2nd offense –name taken and written down and comp given for day, 3rd offence-person must purchase replacement pass for \$15.00 or a day ticket prior to using Howelsen. 4. Skiing while impaired or under the influence of alcohol, any narcotic or other drugs (unless prescribed), or skiing in any closed areas are violations of the ski area regulations as well as the laws of the State of Colorado. The above violations as well as reckless or careless skiing and crowding into lift lines will result in the loss of your season pass without refund. 5. The Colorado Skier Safety Act requires the following: Warning: under Colorado law, a skier assumes the risk of any injury to person or property resulting from any of the inherent dangers and risks of skiing and may not recover from any ski area operator for any injury resulting from any of the inherent dangers and risks of skiing, including: changing weather conditions; existing and changing snow conditions; bare spots; rocks; stumps; trees; collisions with natural or man-made objects, or other skiers; variations in terrain; and the failure of skiers to ski within their own abilities. 6. Any individual who is under the age of 18 will need permission by a parent or guardian for the purpose of reading and signing this contract. The pass holder and the parent or guardian signing the contract agrees that each skier under the age of 13 will be accompanied and supervised by an adult at all times, while at the ski area. I the participant or guardian of participant, understand that the activities registered for contain an element of hazard or risk. I recognize the inherent danger involved and take full responsibility for my actions and physical condition of myself and my child/ward. I agree to indemnify and hold the City of Steamboat Springs and any cooperating agencies involved in the activities and any of their servants, agents or employees free and harmless from any liability, loss, cost or expense including attorney’s fees, , which may result from participation in the activities. I agree I am solely responsible for payment of all costs resulting from the rendering of medical aid and ambulance services to the participant and I authorize that all necessary first aid steps may be taken as prescribed by qualified personnel. By signing above, I agree, understand, and consent to this statement and all provisions above.
