| Specific Duties | Curriculum coordination - coordinator will be familiar with RSES standards in order to support teachers and students Scheduling – oversee the intricacies of all scheduling for students, teachers, SSCV and special academic needs Student support available to assist with missed work at after school program on Wednesdays and Fridays when RSES is in session during the U8/U10 regular season Work with students to establish plans when falling behind Meeting and communications with teachers 1-2 x per month as needed to stay abreast of student progress as well as meet with RSES principal 1-2 x per month to stay abreast of student progress and overall cooperative program weekly, as needed, to inform RSES staff and administrators of unique schedules, travel race days and training and competitions requiring students to miss school for championships, etc. with students in after school program |

 - (i) from start of regular season U8/U10 on-snow program in approximately mid-November through the end of the U8/U10 regular season (approximately April 16, 2021):
 - (a) working from 11:30 am* 1:30 pm* on Wednesdays and Fridays when RSES is in session (which among other things contained in the job description, includes arriving at RSES in Vail at 11:30 am*, meeting with teachers to coordinate after school work, gathering and getting students to Vail Mountain on time for their U8/U10 Age Class Program training on the town bus); and
 - (b) working from 3:30 pm* 5:45 pm* on Wednesdays and Fridays when RSES is in session (which among other things contained in the job description, includes returning students to RSES from Vail Mountain on the town bus after training, running an after school study hall at RSES upon return to school from 4:30 pm* 5:30 pm* after training and staying with children until parents pick them up from these after school study halls) (*please note the above times may vary slightly based on lift operation times, etc.) plus
 - (iii) an additional eight ten hours per week for other responsibilities of the position throughout the employment period whether or not RSES is in session, including communications, updating the tracking spreadsheet on an ongoing basis, writing monthly program report, collaboration with SSCV Advancement Manager, coordination of possible community related activities, program launches and marketing and admissions related events for current and future Red Sandstone Cooperative Programs

In addition to the above there may be some early season training related after school study halls twice a week prior to the start of the above-referenced regular season and some post season training related after school study halls twice a week after the end of the above-referenced regular season through as late as April 16, 2021.
